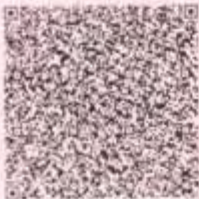

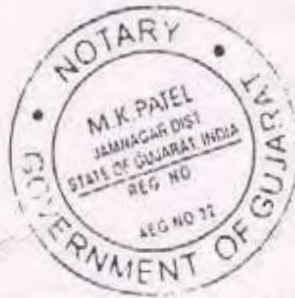

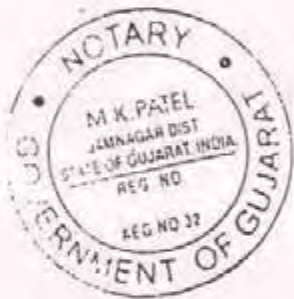
(4) Main aims:-

(6) Accounting year:-

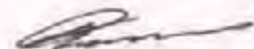
The first accounting year of this institution will be end on 31/3/1997 and thereafter will be ending in March of each year.

(11) Method of appointment and removal of the trustees:-

- (1) The present number of the trustees of this trust in five. The maximum number of the trustees will be 9. For completing this number, trustees can appoint additional trustees by passing resolution as they deemed fit.
- (2) Whenever there will be place trustees will be fall, vacant for any reason, it can be filled up by appointing new trustees by the remaining trustees of the trust.
- (3) The office bearers as shown in this trust deed shall be deemed to be "permanent trustees" remaining trustees will be continuous as member trustees, trustees will appoint President, Vice-President, secretary, Jt- Secretary and Treasurer from amongst them.
- (4) If "permanent trustees" give resignation for their personal wish or died, then its place shall be deemed to place "fall vacant" and a that vacant place remaining trustee can appoint trustees for them or Siddhi Vinayak Education Trust

- (5) Any person who have attained age of 18 years and is residing in Jamnagar District since one year and who respect the aim and working policy of the trust, can be appointed on trustee in this trust. If any trustees will found working against the aim and working policy of the trust, then after proper and sufficient investigation unanemously by all remaining trustees, he can be removed and relieved from the trust and shall not be re-appointed for minimum two years as trustees.

(12) Newly appointed trustees:-

- (1) The newly appointed trustees appoint as per the provision of the trust deed to give their written consent as their appointment as trustees.
- (2) Newly appointed trustees shall have right authority and duties as that of trustee

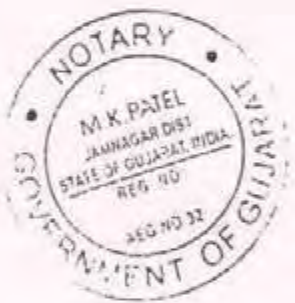

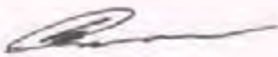
